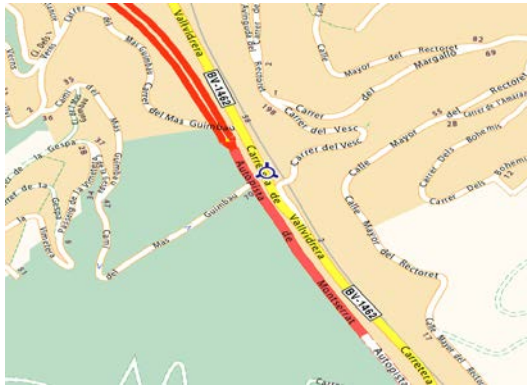
### **Participants**
